



Post Graduate Degree Experience Credit

If you have a completed Masters or PhD degree in engineering, geology or geophysics, the APEGGA Board of Examiners may grant experience credit towards the 48 months of experience required for registration.

Available for P.Eng., P.Geol., P.Geoph. and Foreign Licensee applicants only.

Post-graduate degree experience credit is not assessed if you are applying for enrollment as an E.I.T., Geol.I.T. or Geoph.I.T. Post-graduate experience credit is assessed only at the time you apply for professional registration as a P.Eng., P.Geol., P.Geoph. or Foreign Licensee.

Post-graduate degree experience credit is available only if your post-graduate degree is from a CEAB or MRA accredited institution. CEAB refers to Canadian engineering institutions. Canada has entered into Mutual Recognition Agreements (MRA) with a number of countries who have accreditation systems in place similar to Canada. These countries and agreement dates include the USA (dates listed on accreditation list), UK (1989), Ireland (1989), Australia (1989), New Zealand (1989), Hong Kong (1995), South Africa (1999), France (dates listed on accreditation list) and Japan (2005).

Please refer to the information below for an indication of how much experience credit you may be eligible to receive and for which documentation you will be required to supply with your application.

- ✓ Transcripts must be forwarded directly to APEGGA from your educational institution.
- ✓ Thesis/Project Information includes: copies of the title page, abstract page, recommendation and conclusion portion of your thesis/project report and a letter of recommendation directly from your thesis supervisor to APEGGA which includes a statement about the engineering/geology/geophysics experience and the value of the thesis or project research.

If your Undergraduate Degree is – CEAB or MRA and your Masters or PhD degree is CEAB or MRA

Course Based Masters – Up to 6 Months of Credit

- ✓ Please provide an official transcript directly from your educational institution and course descriptions.

Course and Project Based Masters – Up to 12 months credit

- ✓ Please provide an official transcript directly from your educational institution and project information.

Course and Thesis Based Masters – Up to 18 months credit

- ✓ Please provide an official transcript directly from your educational institution and thesis information.

Course and Thesis Based PhD – Up to 24 months credit

- ✓ Please provide an official transcript directly from your educational institution and thesis information.

If your Undergraduate Degree is not CEAB or MRA and your Masters or PhD degree is CEAB or MRA

Course Based Masters – No Credit given

Course and Project Based Masters – Up to 6 months credit

- ✓ Please provide an official transcript directly from your educational institution and project information.

Course and Thesis Based Masters – Up to 12 months credit

Course and Thesis Based PhD – Up to 18 months credit

Pre Graduate Work Experience Credit

The APEGGA Board of Examiners may grant experience credit for experience gained prior to you receiving your undergraduate degree in engineering, geology or geophysics. The Board may grant up to 12 months credit for acceptable engineering, geology or geophysics work experience obtained after academic term 5.

In a typical 4 year undergraduate program the only applicable work experience after academic term 5 would be work experience obtained during the summer between 3rd and 4th year.

Available for P.Eng., P.Geol., P.Geoph. and Foreign Licensee applicants only.

Pre-graduate work experience credit is not assessed if you are applying for enrollment as an E.I.T., Geol.I.T. or Geoph.I.T. Pre-graduate work experience credit is assessed only at the time you apply for professional registration as a P.Eng., P.Geol., P.Geoph. or Foreign Licensee.

Please refer to the information below to determine how much experience credit you may be eligible to receive and the documentation you will be required to supply with your application.

Co-op and Internship programs could receive up to 12 months credit.

- ✓ Please provide the name and contact information of the P.Eng./P.Geol./P.Geoph. reference(s) for your co-op or internship work experience.
- ✓ Include a detailed description of this work experience in your resume.

Summer Work could receive up to 4 months credit.

- ✓ Please provide the name and contact information of a P.Eng./P.Geol./P.Geoph. reference for your summer work experience.
- ✓ Include a detailed description of this work experience in your resume.
