# **MINUTES**

## 15.2 Other Issues

The following statements, questions, and concerns were put forward by members:

- Alberta has an excellent industry but it doesn't seem that remuneration in this industry has risen at the rate of some of the management consulting firms, lawyers, other professions.
- There was concern expressed at the low turn out of members aged thirty years and younger.
- There was a question of whether Canada should negotiate reciprocity with other countries who are less parochial in their handling of licensing and regulation of the professions than the United States, such as Britan and Austrailia, etc. If the US sees that they are being left behind, they may feel more encouraged to step up and cooperate. Mr. Richard Hancock, P. Eng., Chair of the Board of CCPE answered in the positive. Dr. Gordon Williams, P. Geol., representing CCPG replied that mobility was the top priority for the geoscience constituency and for CCPG.

## 16. INDUCTION OF PRESIDENT ELECT

Out-going President Darrel Danyluk presented the Certificate of Office to in-coming President Sue Evison who read and declared the Oath of Office of the President of the Association of Professional Engineers, Geologists and Geophysicists of Alberta.

Ms. Evison thanked the membership for the honour of being elected as APEGGA's president for the 2000/2001 year. She is humbled by the support she has received from APEGGA's staff and members of APEGGA; her employer, Klohn-Crippen; her friends and family.

Ms. Evison commented on one key direction that the Association will be taking in the 2000/2001 year, that of the "relevance" of APEGGA.

In closing, President Evison again thanked the membership for their support and stated that she looks forward to demonstrating that she is worthy of the confidence the membership has expressed in electing her to be the Association's 81<sup>st</sup> President.
